ORDER

As per letter read as 1st paper above the Additional Statistical Adviser, Ministry of Agriculture & Farmers Welfare Department of Agriculture & Farmers Welfare Economics, Statistics & Evaluation Division, has requested to suspend all the new recruitment under the scheme Viz; Timely Reporting Scheme (TRS), Improvement of Crops Statistics (ICS) and Establishment of an Agency for reporting Agriculture Statistics (EARAS) in the state until further order, as many States are moving towards technological intervention in collection & compilation of Crop Statistics such as Digital Crop Survey.

Accordingly, as per the letter read as 2nd paper above, instructions were given to the Director, Economics & Statistics Department to suspend all the new recruitment under the scheme Viz; TRS/ICS/ EARAS with immediate effect. Subsequently, as per letter read as 4th paper above, the Director, Economics & Statistics Department has requested to give permission to resume the recruitment for EARAS scheme based on the new guidelines issued by Government of India as per letter read as 3rd paper above .

2. Government have examined the matter in detail and are pleased to give permission to resume the filling up of existing vacant posts which would come under the sanctioned strength of Establishment of an Agency for reporting Agriculture Statistics scheme (EARAS) for which full reimbursement is receivable from Government of India for salary expenditure.
