ORDER

As per the letter read as 1st paper above, the Government of India has issued first Mother sanction for Rs.112.63 crore as Grants-in-aid for Flexible Pool for RCH and Health System Strengthening, National Health Programmes and Urban Health Mission under National Health Mission for 2026-27. As per the letter read as 2nd paper above, the NHM has requested to release the Central grant along with corresponding State Share amounting to Rs.187,71,66,667/- (Rupees One Hundred and Eighty Seven Crore Seventy One Lakhs Sixty Six Thousand Six Hundred and Sixty Seven only) under the Head of account 2210-06-101-19-02 (PV) in SPARSH mode

for the implementation of programmes approved by Government of India for 2026-27.

2) As per the G.O read as 3rd paper above, an amount of Rs.25,36,67,000/- (Rupees Twenty Five Crore Thirty Six Lakh Sixty Seven Thousand only) has been reappropriated from the HoA "2210-06-101-19-02" to the HoA "2210-06-789-99-02" (Rs.21,26,67,000/-) and to the HoA 2210-06-796-95-02" (Rs.4,10,00,000/-) for the above purpose.

3) Government have examined the matter in detail and are pleased to release an amount of Rs.187,71,66,667/- (Rupees One Hundred and Eight Seven Crores Seventy One Lakh Sixty Six Thousand Six Hundred and Sixty Seven only) (Rs.112.63 crores as Central Share and Rs.75,08,66,667/- as State share) in SNA SPARSH mode under General, SC and ST heads of the state for the implementation of programmes approved by GoI for 2026-27, as per the following;
