ORDER

As per the order read as 1st paper above, the Administrative Sanction for an amount of Rs.4,90,00,000/- (Rupees Four crore Ninety Lakhs only) has been accorded by National Ayush Mission, for the work “Construction of 50 Bedded Integrated Ayush Hospital for Pazhassiraja Government Ayurveda Dispensary at Mattannur-Pahse III (Civil works, Electrical works, Mechanical works, ELV works, PHE works and Interior, Exterior & Furnishing works)”. The amount was approved in SAAP 2023-24 of NAM. The National Ayush Mission has allotted the said work to M/s Uralungal Labour Contract Co-operative Society Ltd, as Non-PMC. As per the letter read as 3rd paper above, the State Mission Director, National Ayush Mission has requested to accord Technical Sanction for the aforesaid work. The Technical Sanction Committee constituted as per the Order read as per 2nd above convened on 30/12/2025 scrutinized the detailed estimate furnished by the National Ayush Mission, and accord Technical Sanction for the work as detailed in the minutes read as 4th paper above.

2) Accordingly, Government are pleased to accord Technical Sanction for an amount of Rs. 3,98,26,709.74/- (excluding GST) for the work “Construction of 50
