ORDER

As per Government Order read as 1st paper above, Government have accorded sanction for the release of 4th & final installment of 'Child Development Centre' for an amount of ₹83,85,000/- under the Head of Account "2210-05-105-50-36(P)- Grant-in-Aid-General-Non Salary" from 2025-2026 year's budget provision.

2. The Director- in -charge of Child Development Centre in its letter read as 3rd paper above has reported that due to treasury restriction, it was unable to submit the pending bills/claims to treasury. Therefore on 31st March, 2025, a total amount of ₹83,91,545/- including the unspent balance amount has been resumed to Government. And therefore the Director (i/c) has reported that the monthly salary of daily wages/contract employees from January 2026 and other inevitable works at Child Development Centre are pending

due to the non availability of Government Grants and it was adversely affecting the day-to-day activities of CDC. Since the Centre is being operated with the Grant-in-Aid provided by Government; Plan Fund from Government is inevitable for providing better healthcare to the children suffering from various developmental disorders. Hence Director (i/c) has requested to refund the resumed fund of ₹83,85,000/- to settle the pending claims from January 2026 onward.

3. Government have examined the matter in detail and are pleased to refund an amount of **₹83,91,545/- (Eighty Three Lakhs Ninety One Thousand Five Hundred and Forty Five only)** under the H/A "22 10-05- 105-50-36" **Grant-in-Aid-General-Non Salary (Plan)** which was resumed during the financial year 2025-2026, from the current year's budget provision, subject to the condition that the action must be ratified in the first meeting of the Departmental Working Group itself.
