ORDER

As per the directives of Election Commission of India, the EVMs and VVPATs found non-functional during the First Level Checking need to be send to the manufacturer for repair.

2) As per the letter read as 1 st paper above, M/s. Fast & Economic CCFCTC, Thiruvananthapuram was entrusted with the work of shifting the non-functional units available in the districts of Kerala to BEL, Bangalore in covered trucks equipped with GPS.

3) M/s. Fast & Economic CCFCTC has transported non-functional 1100 Ballot Units, 4158 Control Units and 3859 VVPAT Units to BEL, Bangalore and has furnished a bill for an amount of ₹8,97,040/- (Rupees Eight Lakh Ninety Seven Thousand and Forty Only) towards the transportation charges.

4) Having examined the matter in detail, Government are pleased to accord sanction to release an amount of ₹8,97,040/- (Rupees Eight Lakh Ninety Seven Thousand and Forty Only) (inclusive of GST) to M/s. Fast & Economic CCFCTC, Thiruvananthapuram towards the transportation charges of non-functional EVMs and VVPATs to M/s. BEL, Bangalore.

5) The expenditure in this regard will be met from the Head of Account "2015-00-106-99-34-OC" from the current year's budget.

6) The Election (Accounts) Department will make necessary arrangements for the payment of the amount in favour of M/s. Fast & Economic CCFCTC, Thiruvananthapuram, after realising statutory deductions, if any.
