ORDER

The Ministry of Rural Development (MoRD), GoI, had, vide letters read as 2nd and 3rd papers above, issued Mother Sanction to release ₹82.8116 crore and ₹184.2734 crore as the 1st Installment of the 1st Tranche of Central Assistance towards Administrative component (100% CSS) and Material component (75% CSS) respectively under SNA SPARSH for the year 2026-27 for the implementation of MGNREGA in the State. The Mission Director, MGNREGS has, vide letter read as 4th paper above, submitted proposal for the release of the Central Assistance along with its matching State share under SNA SPARSH.

2. Government have examined the matter in detail. The total amount to be released under Material component is ₹245.6978667 crore including corresponding State share (75:25) of ₹61.4244667 crore. Under SNA SPARSH bills must be prepared exclusively through the State Head of Account, if there is State share. The available balance under the

corresponding State share head is insufficient to release the entire amount under Material component.

3.In the circumstances, Government are pleased to accord sanction to release an amount of ₹229.34 crore towards Material component as partial release of the Central share and its corresponding State share and an amount of ₹82.8116 crore towards Administrative component for the Financial Year 2026-27 for the implementation of MGNREGS in the State, from the current year's budget provision, as shown below;
