ORDER

WHEREAS, it has been disclosed from the records of investigation in CB Crime No.611/CB CU-III/KKD/12 that the accused [A1] Remains unidentified, had obtained Indian Passport bearing No. H 6710565 by submitting forged documents before RPO, Kozhikkode with the knowledge and assistance of [A2] Balan M.V, S/o Ambu, Age:54/21, Amboos House, Ajanoor, Kolavayal P O, Kasargod, [A3] E P Chandran, Age 53/21, S/o Krishnan, Edadan Puthiya Veedu, Muthathi, Koram Village & [A4] V Asokan, Age 59/21, S/o Kunhiraman, Keerthi Nivas, Puthukai P O, Kanjangad, Kasargod. Thus the accused person [A2] had committed offences

intentionally and is there by punishable under sections 109, 120 B, 420 r/w 34 of Indian Penal Code, 1860 and section 12 (2) of Passport Act, 1967 and accused persons [A3] & [A4] had committed offences intentionally and is there by punishable under sections 465, 468, 471, 109, 120 B, 420 r/w 34 of Indian Penal Code, 1860 and section 12 (2) of Passport Act, 1967.

AND WHEREAS, the Government of Kerala after careful examination of the records of investigation in CB Crime No.611/CB CU-III/KKD/12 are fully satisfied that the aforesaid accused persons, [A2] Balan M V, [A3] E P Chandran & [A4] V Asokan, committed offences punishable under section 12(2) of Passport Act, 1967 along with other offences for which they should be prosecuted.

AND WHEREAS, Department of Posts, Government of India, as per the order read as 2nd paper above have accorded sanction under section 197 of CrPC for prosecuting the accused [A2] Balan M V, under criminal law.

AND WHEREAS, Government of Kerala as per order read as 3rd paper above have accorded sanction under section 197 of CrPC for prosecuting the accused [A3] E P Chandran & [A4] V Asokan, under criminal law.

NOW THEREFORE, Government of Kerala, in exercise of the powers conferred by section 15 of the Passports Act, 1967 read with Government of India notification No. GSR 662(E), dated 01.12.1979 of the Ministry of External Affairs do hereby, accord sanction to prosecute the aforesaid accused persons [A2] Balan M V, [A3] E P Chandran & [A4] V Asokan, for the offences punishable under section 12(2) of the Passports Act, 1967, in Crime No.611/CB CU-III/KKD/12 and for taking cognizance of the said offences by a court of competent jurisdiction.
