**ORDER**

The Chief Engineer (Roads), as per his letter read above, has requested to accord Administrative Sanction for the work "Improvements including providing BM & BC to Chundaparamba - Pooparamba - Nellikutty - Areekkamala - Vellad - Karuvanchal Road Km 16/000 to 22/000 in Irikkur for an amount of ₹ 900 Lakh (Rupees Nine hundred Lakh only) under the h/a 5054-04-337-99-MDR

2) Government have examined the matter in detail and are pleased to accord Administrative sanction for the work "Improvements including providing BM & BC to Chundaparamba - Pooparamba - Nellikutty - Areekkamala - Vellad - Karuvanchal Road Km 16/000 to 22/000 in Irikkur LAC for an amount of ₹ 900 Lakh (Rupees Nine hundred Lakh only) under the h/a 5054-04-337-99-MDR subject to the compliance of the following observations while issuing the Technical Sanction:

1) The necessity of improving the road with BM&BC may be

confirmed with due consideration for durability, economy, traffic volume and importance of road

2) The width of berm concreting proposed @1.20m shall be optimized to the standard width of 50cm on both sides

3) The scarified materials shall be accounted properly;which can be used for filling below the GSB layer or at shoulders with proper compaction

4) The estimate shall be revised based on current SoR i.e DSoR 2021

5) The estimate provision for utility shifting shall be regulated based on estimates submitted by the concerned utility.
