### ORDER

In the State Plan Scheme 2025-26, an amount of Rs.1700 Lakh has been allocated in the head of account 2055-00-115-98-02 (PV), for the implementation of the scheme 'Student Police Cadet'(SPC) .

2) As per letter read as 5<sup>th</sup> paper above, the State Police Chief has furnished a proposal, requesting to accord Administrative Sanction for an amount of Rs.1700 Lakh for the Scheme 'Student Police Cadet', under the State Plan Scheme 2025-26 as follows:

3) The Special Working Group meeting held on 04.07.2025 has decided to give Administrative Sanction for an amount of Rs.16.3637 Crore (Rupees Sixteen Crore Thirty Six Lakh and Thirty Seven Thousand Only) for Student Police Cadet Project.

4) In the above circumstance, Government are pleased to accord administrative sanction for an amount of Rs.16.3637 Crore (Rupees Sixteen Crore Thirty Six Lakh and Thirty Seven Thousand Only) under the Head of

Account 2055-00-115-98-02(PV), for the above mentioned activities in the Student Police Cadet Scheme for the year 2025-2026, subject to the following terms and conditions.

- i. The expenditure shall be met from the provision available under the appropriate head of account.
- ii. The fund release will be based on actual requirement and the fund released should not be parked in banks.
- iii. Store Purchase Rules shall be strictly adhered to, if applicable.
- iv. Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
- v. Post creation and purchase of vehicles are not admissible under the scheme.
- vi. Components of the scheme with detailed break-up & estimates, period of completion of the project, mode of implementation of the project, name of implementing agency, funding pattern, release of funds and details of monitoring mechanisms, head of account to debit the expenditure, physical target, output, outcomes and deliverables of the scheme, etc. shall be specified in each proceedings issued by the Department, as stipulated in Government order read as 1<sup>st</sup> paper above.
- vii. For hiring of project staff/man power as part of project implementation, instructions issued in the Government orders read as 2<sup>nd</sup> and 3<sup>rd</sup> paper above shall be followed.
