ORDER

Sree Palakkottu Bhagavathi Temple, located at Thirichilangadi in Feroke, Kozhikode District, is a historically and culturally significant temple in the region. The temple is known for its traditional rituals, annual festivals, and strong participation of devotees from surrounding localities.

2. As part of development of pilgrim facilities under Pilgrim Tourism scheme, the Director of Tourism as per the letter read above has submitted the project proposal " Development of Pilgrim Tourism Facilities at Palakkottu Bhagavathi Temple, Thirichilangadi, Feroke, Kozhikode" for an amount of Rs.10,10,000/-(Rupees Ten Lakh Ten Thousand only) from the Head of Account, "5452-01-101-99-00-34-03-Up Gradation, Creation of Infrastructure and Amenities (Plan)" before

the Departmental Working Group meeting. The working group meeting held on 19.02.2026 approved the proposal subject to certain conditions:

3. Government have examined the project proposal in detail and are pleased to accord Administrative Sanction for the project “Development of Pilgrim Tourism Facilities at Palakkottu Bhagavathi Temple, Thirichilangadi, Feroke, Kozhikode” for an amount of Rs.10,10,000/- (Rupees Ten Lakh Ten Thousand only) under the Head of Account 5452-01-101-99-00-34-03-Up Gradation, Creation of Infrastructure and Amenities (Plan) subject to the following conditions.

(i). The department/implementing authority should ensure that the work should be intended for enhancing the tourism potential of the locality and liability on infrastructure development of the temple shall not be the responsibility of the Government in future.

(ii). The Deputy Director kozhikode should ensure that the Government norms regarding pilgrim tourism development are satisfied.

4. The Director of Tourism shall ensure that all the procedural and codal formalities and the conditions stipulated in the Government Orders read above are strictly adhered to.
