ORDER

The XVth Finance Commission of India has recommended an amount of ₹586.95 crore as grant-in-aid for Health Sector to be channelized through Local Governments for the year 2023-24. Out of this, ₹105.6777 crore for 3 schemes were released to the state in 2024-25.

2) The Director, FCD vide, letter read as 6th paper above, has conveyed the release of Health Sector Grant for Support to Diagnostic Infrastructure in the primary health care facilities of the Urban PHCs under XVth Finance Commission amounting to ₹11.0436 crore for the year 2023-24. It has been requested to transfer the grant-in-aid directly to the Department concerned authorized by the State Level Committee for procurement under the component – Support to Diagnostic Infrastructure in the primary health care facilities of the Urban PHCs.

- 3) As per Govt order read as 5th paper above, the method of transfer of Health Sector Grant has been modified in accordance with the Govt of India guidelines.
- 4) Government, after having examined the matter in detail, are pleased to transfer an amount of ₹11,04,36,000/- (Rupees Eleven crore Four lakh Thirty Six thousand only) as Health Sector Grant for Support to Diagnostic Infrastructure in the primary health care facilities of the Urban PHCs under XVth Finance Commission for the year 2023-24 released by Government of India on 24/03/2025.
 - 5) The Under Secretary, Finance (Accounts) Department is authorized to transfer credit the amount from the head of account to the Bank account of Finance Department opened for this scheme/ component and therefrom to the Bank account of the Urban Affairs Department (o/o the Director (Urban), LSGD)opened for this scheme, as detailed below **on or before 05/04/2025:**
