<u>ORDER</u>

As per the Government Order read as 1^{st} paper above, administrative sanction was issued for setting up of "Smart Data Centre with Hybrid Cloud Compatible and Hyper Converged Infrastructure" in the premises of Kerala University of Digital Sciences, Innovation and Technology (Digital University Kerala), at an estimated amount of ₹25 Crore. An amount of ₹25 Crore was released as per G.O read as 2^{nd} above to the Digital University Kerala for the Smart Data Centre project from the financial assistance received under Part-IV of the Scheme for Special Assistance to States for Capital Investment 2022-23 debiting the expenditure from the Head of Account 4859-02-004-88-01. At the end of financial year 2022-23 and 2023-24, the amount remaining in the PSTSB account was resumed and released subsequently vide Government orders read as 3^{rd} and 4^{th} above. On 30.03.2025, the remaining balance amount of R,46,64,202/- available in the PSTSB account was again resumed.

2. Now, as per the letter read above, the Registrar, Kerala University of Digital Sciences, Innovation and Technology has requested to release the above amount for the timely implementation of the Smart Data Centre project. As per the G.O read as 6^{th} paper above Government have additionally authorized an amount of **₹** 8,46,65,000/ under the Head of Account "4859-02-004-88-01-Smart Data Centre under DUK(P)(V).

3. Government examined the matter and are pleased to accord sanction for the release of **₹** 8,46,64,202/- (Rupees Eight Crore Forty Six Lakh Sixty Four Thousand Two Hundred Two only) by debiting the expenditure from the Head of Account "4859-02-004-88-01-Smart *Data Centre under DUK(P)(V)*" against the fund resumed from their PSTSB Account No. 799012700002180. This release shall be subject to the conditions specified in the Government Order read as 2 nd paper above and the general terms and conditions of fund release.

4. The Under Secretary (E&IT) shall draw the amount and transfer credit the same in favour of the Kerala University of Digital Sciences, Innovation and Technology in the PSTSB Account

No.799012700002180 which shall be drawn according to actual requirement only.
