As per letter read above, the Chief Engineer, Buildings has furnished a detailed estimate amounting to ₹100 Lakhs for the 'Vertical extension of New building for University Institute of Technology Sasthamcotta Technology Sasthamcotta (Construction of First Floor & terrace floor)' prepared based on the DSR 2018 & GST 18% for according Administrative Sanction.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work "Vertical extension of New building for University Institute of Technology Sasthamcotta (Construction of First Floor & terrace floor)" for an amount of ₹100 Lakhs under the Head of Account 4059-01-051-86(P) subject to the following conditions:

1. The Chief Engineer, Buildings shall ensure that the works proposed in the estimate shall satisfy the functional requirements as envisaged.

2. The competent TS authority shall ensure the admissibility of provisions included in the estimate with site conditions before issuing Technical Sanction.

3. TS authority shall ensure the structural adequacy and structural stability of the building based on structural design before issuing Technical Sanction considering economy.
4. The grade of concrete for the proposed construction shall be reviewed as per IS code while issuing TS.
5. TS authority shall ensure that the quantities in the Estimate are arrived based on design drawings before according TS.
6. The correctness of the rates adopted for observed data included in the estimate shall be ensured by the TS authority.
7. Detailed estimate for the electrical works shall be prepared before issuing TS.

The Chief Engineer, Buildings, PWD shall ensure that the aforesaid conditions are adhered to.
