Smt. Neenamma Kurien, Managing Partner of the firm Integral Solutions, a firm engaged in the work of carrying out investigation & Design works of Buildings during the period 2012-2016. Petitioner's firm was granted various work orders under the Kottayam, Malappuram, Kozhikode, Ernakulam & Wayanad PWD divisions for conducting Soil Investigation and for providing Architectural & Structural Designs.

- 2) Smt. Neenamma Kurien filed WP(C) 25797/2023 alleging that the payment for the works done in the above mentioned 5 districts are due for a very long time. As per the Judgment read above, the Hon'ble High Court directed that the Petitioner be heard by the competent among the Respondents 3 to 7 and eligible amounts be disbursed to the Petitioner not later than 3 months from the date on which such Representations are preferred. 1
- 3) As per letter read as 2nd paper above, the Chief Engineer, Buildings has furnished a proposal for granting payment & details of works & amount for which Smt. Neenamma Kurien is eligible i.e an amount of Rs. 16,40,675/- (Rs. Sixteen lakhs forty thousand Six hundred and Seventy five) under the Head of Account 4059-01-051-63-PV for 2 works & Head of Account 4059-60-051-68-PV for other 16 works.
