## **ORDER**

In the Annual Plan Budget 2025-26 an amount of Rs.80,00,00,000/000/has been provided under the Head of Account '2210-01-110-24-34OC(P)' for the implementation of the Scheme 'Kerala Emergency Medical Services Project (108 Ambulance) - KANIVU'. As per the letter read as 1<sup>st</sup> paper above, the Director of Health Services has forwarded a proposal furnished by the Managing Director of KMSCL, seeking Administrative Sanction for an amount of Rs.1,71,09,03,600/- with permission to meet an expenditure amounting to Rs.80,00,00,000/- from the budget allocation for the FY 2025-26 under the head of account '2210-01-110-24-34OC (P)' as detailed below.

The Director of Health Services has sought Administrative Sanction for the aforementioned proposal with permission to meet an amount of Rs.80,00,00,00,000/- from the Head of account '2210-01-110-24-34-OC (P) and an amount of Rs.51,93,00,000/- from the PIP Kerala of National Health Mission. The remaining amount of Rs.39,16,03,600/- required for the project is proposed to be allocated through Additional Authorisation.

**2.** The 3<sup>rd</sup> Special Working Group meeting held on 12.06.2025 examined the aforementioned proposal from the Director of Health Services and decided to approve the same as detailed in the minutes read as 3<sup>rd</sup>

Accordingly, Comprehensive Administrative Sanction is hereby accorded for the implementation of the Scheme 'Kerala Emergency Medical Services Project (108 Ambulance) - KANIVU' for an amount of Rs.1,71,09,03,600/- (Rupees One Hundred and Seventy One Crore Nine Lakh Three Thousand and Six Hundred Only) with permissions to meet, the expenditure amounting to Rs.80,00,00,000/- (Rupees Eighty Crore Only) from the State Plan fund under the head of account '2210-01-110-24-34OC(P)' and the expenditure amounting to Rs.51,93,00,000/- (Rupees Fifty One Crore and Ninety Three Lakh Only) from the the PIP Kerala of National Health Mission. The Director of Health Services shall furnish proposal for Additional Authorisation to meet the remaining expenditure of Rs.39,16,03,600/-, if required.
- **4.** The Director of Health Services and the Managing Director, KMSCL shall ensure that quality parameters are monitored properly, service level agreement has to be fulfilled and expenditure shall be limited to sanctioned amount. The State Mission Director, National Health Mission, the Director of Health Services and the Managing Director, KMSCL shall also ensure that the amount over and above the budget provision i.e. Rs.51,93,00,000/-(Rupees Fifty One crore and Ninety Three lakh only) will be made available from the NHM.
- 5. KMSCL shall be the implementing agency of the project. The fund release shall be based on actual requirement and the fund released should not be parked in banks. The expenditure would be met from the provision available under the appropriate head of account and it should be utilized only for the purpose for which it is allotted. Post creation and purchase of vehicles are not admissible under the scheme. Store Purchase Rules shall be strictly adhered to. Tender /e-tender and other stipulated formalities shall be followed wherever necessary. For hiring of project staff/man power as part of project implementation, instructions issued in G.O(P)No.76/2019/Fin.

Dated 02.07.2019 and G.O(P)No.81/2019/Fin dated 09.07.2019 shall be followed.
