ORDER

The Registrar General, High Court of Kerala, vide the letter read above, has informed that six vehicles of the High Court, having completed fifteen years from the date of initial registration, were condemned and disposed of through MSTC e-auction in accordance with the applicable Government orders and the guidelines issued by the Ministry of Road Transport and Highways, Government of India. The vehicles were utilized for various administrative and operational requirements of the High Court.

2.The six condemned vehicles were disposed of through MSTC e-auction and an amount of ₹1,89,999/- was realised as scrap value. As per MSTC Acceptance Letter/Sale Order No. MSTC/TVC/25-26/4441 dated 13.11.2025, the sale was completed on 23.10.2025, and the amount realised has been remitted to Government under the Head of Account “0070-01-800-95 – Other Items”.
