**ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, Administrative sanction was accorded to the Director of Tourism to expend an amount of 5,14,21,500/- (Rupees Five Crores Fourteen Lakhs, Twenty One Thousand Five Hundred Only) including GST for the project 'Participation of Kerala Tourism in International Trade Fairs 2024-25', by meeting the expenditure from the funds available under the h/a 3452-80-104-98-00-34-03- PV- Marketing(Plan).

2. Based on the orders issued in 2<sup>nd</sup> and 3<sup>rd</sup> papers above, the department had submitted proposals that were prioritized for the FY 2024-25 to be placed before the Chief Secretary's Committee constituted as per the order read as 2<sup>nd</sup> paper above. The Chief Secretary's Committee meeting held on 04.10.2024 had approved the project by limiting the Administrative Sanction amount to the tune of ₹ 4,52, 88,000/- .

3. Government have examined the matter and are pleased to

modify the Government Order read as 1<sup>st</sup> paper above, by limiting the Administrative Sanction amount to ₹4,52,88,000/-only including GST (Rupees Four Cores Fifty Two Lakhs Eighty Eight Only including GST), subject to the condition that the Director of Tourism shall prioritise the components by prioritising the components as per the requirement.
