Stores Purchase Department - Forest Industries (Travancore) Limited (FIT), Aluva - Supply of wooden furniture (Teak, Anjili, Hard Wood, Accasia) to Government Departments / Public Sector Undertakings / Local Self Government Institutions / Autonomous Bodies etc - without following tender formalities -Relaxation of para 9.23 of Store Purchase Manual -Period of validity extended-Orders issued.

ORDER

As per the Government Order read as 1st paper above, M/S Forest Industries (Travancore) Limited (FIT) was permitted to supply selected items of Wooden furniture directly to Government Departments / Public Sector Undertakings, Local Self Government Institutions etc without tender formalities , at the rate fixed by the Government for a period of one year from 28.10.2023 in relaxation to para 9.23 of revised Stores Purchase Manual .

2. Now the Managing Director, Forest Industries (Travancore) Limited (FIT) vide letter read as 2 nd above has requested to extend the validity of the aforesaid relaxation for a period of one more year , since the same has expired on 27.10.2024.

3. Government have examined the matter in detail and are pleased to grant tender exemption to M/S Forest Industries (Travancore) Limited, by relaxing para 9.23 of the revised Stores Purchase Manual for a period of one year from the date of issue of this Order ,so as to enable M/S Forest Industries (Travancore) Limited, to supply wooden furniture manufactured by the firm directly to all Government Departments /

Public Sector Undertakings, Local Self Government Institutions etc without observing tender formalities, subject to the condition that the selling price of items should not exceed to the rate fixed as per the

Government Order read as 1 st above.

4. The Purchasing Officer should ensure that the validity period of relaxation in para 9.23 of revised Stores Purchase Manual is in force at the time of direct purchase and for the purchase of items which are not included in the price list, other procurement modes as per the norms contained in the Stores Purchase Manual shall be resorted to.
