**ORDER**

Government, as per order read as 2<sup>nd</sup> paper above, have accorded administrative sanction for the purchase of 30 vehicles costing below Rs.10 lakh each for use as Control Room Vehicles, and 8 four-wheel drive vehicles costing below Rs.13 lakh each for use in Police Stations located in hilly areas, by utilising the savings amount of Rs.404 Lakh left under the Scheme for Mobility in the State Plan Scheme 2025-26, subject to the condition that the vehicles shall be allotted to the same locations from where the old vehicles are being replaced.

2) The State Police Chief, as per letter read as 3<sup>rd</sup> paper above, has informed that there is an amount of Rs.458.57 Lakh left as savings out of the amount sanctioned under the component Mobility in the State Plan Scheme 2025-26 and the price of 4WD vehicles available in GeM as per specification prepared by specification committee is above Rs.13 Lakh. It is therefore requested to enhance the unit price of the Four Wheel Drive Vehicles (LMVs) to 17 lakh which are proposed for the use in Police Stations located in Hilly areas.

3) Government have examined the matter in detail and are pleased to

accord revised Administrative Sanction for utilising a total amount of Rs. Rs.436 Lakh (Rupees Four Crores Thirty Six Lakh Only) for the purchase of 8 four wheel drive vehicles at the unit rate of Rs.17 Lakh (by enhancing the unit price of the four wheel drive vehicle from Rs.13 Lakh to Rs.17 Lakhs) and 30 LMVs at the unit rate of Rs.10 Lakh, as shown below;

a) *Price of 30 LMV, at the unit price rate of 10 Lakh - 300 Lakh,*

b) *Price of 8 number of Four Wheel Drive vehicle*

*at the unit price of 17 Lakh - 136 Lakh.*

**Total - 436 Lakh.**
