As per the letter read as 1<sup>st</sup> paper above, the Government of India have sanctioned and allotted second mother sanction for an amount of ₹.16,50,00,000/- as grant-in-aid for PM ABHIM for the FY 2025-26.

As per the letter read as 2<sup>nd</sup> paper above, the State Mission Director, NHM has requested to allot corresponding State Share for an amount of ₹.11,00,00,000/- under the HoA "2210-06-101-09-02(PV) along with the Central Share. As per the G.O read as 3<sup>rd</sup> paper above, an amount of ₹.22.98 Crore has been re appropriated from the HoA "2210-06-101-09-01-PM-ABHIM (CS) (P)(V)' to the Head of Account "2210-06-101-09-02-PM-ABHIM (SS)(P) (V).

2) Government have examined the matter in detail and are pleased to release an mount of **₹.27,50,00,000/- (Rupees Twenty Seven Crore Fifty Lakhs)** (including Central Share for an amount of ₹.16,50,00,000/- (Rupees Sixteen Crore Fifty Lakhs only) and State Share for an amount of ₹.11,00,00,000/- (Rupees Eleven Crore only) from the HoA "2210-06-101-09-02 (PV)" to National Health Mission.
