The Chief Engineer (Roads ), as per letter read above, has submitted estimate based on MoRTH specification with DSoR 2018 for the work 'General -Construction of Pulikkathara Drainage - Pulikkathara drainage to Srankupadi on Farook-Mannur-Kadalundi road - General Civil Work' in Beypore Constituency and has requested government to accord Administrative Sanction for the work for an amount of ₹38 Lakh under the head of Account “3054-03-337-97-Special Repairs” for the financial year 2024-2025.

2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work “General
