## **ORDER**

Sri.P.C.Paulachen was appointed as President, Consumer Disputes Redressal Commission, Kozhikkod as per G.O.1st cited and his term ended on 07.05.2024.

- (2) The Hon'ble High Court in its interim order dated 29.02.2024 in WP(C) No.7999/2024 filed by General Secretary, Confederation of Consumer Vigilance Centre, Thiruvananthapuram has ordered to allow the President, State Consumer Disputes Redressal Commission as well as presidents and members of the District Commissions to continue in the said posts as a temporary measure as per the rule prevailing when they were appointed, till the finalisation of the selection process and consequent appointments are made by Government.
