<u>ORDER</u>

Sri.George Baby was appointed as President, Consumer Disputes Redressal Commission, Pathanamthitta as per G.O.1st cited and his term ended on 16.04.2024.

- (2) The Hon'ble High Court in its interim order dated 29.02.2024 in WP(C) No.7999/2024 filed by General Secretary, Confederation of Consumer Vigilance Centre, Thiruvananthapuram has ordered to allow the President, State Consumer Disputes Redressal Commission as well as presidents and members of the District Commissions to continue in the said posts as a temporary measure as per the rule prevailing when they were appointed, till the finalisation of the selection process and consequent appointments are made by Government.
- (3) Government have examined the matter in detail and in compliance with the order of the Hon'ble High Court, are pleased to order to allow Sri.George Baby, President, CDRC, Pathanamthitta to continue in the said post w.e.f.17.04.2024 as a temporary measure as per the rule prevailing when he was appointed, till finalization of the

selection process and consequent appointments are made by Government.
