ORDER

As per the Govt Order read above, Administration sanction was accorded for two projects under NABARD Tranche XXV namely, "Construction of Modern Hygienic fish market at Nedumankavu in Kareepra Grama Panchayath in Kollam District", for an amount of 502.00 lakh and "the Development of fish seed hatchery at Bhoothathankettu (Phase-II), Ernakulam" for an amount of Rs.1120.00 lakh.

2. As per the letter read above, the Director of Fisheries furnished the drawal application under Rural Infrastructure Development Fund Tranche XXV, in the prescribed proforma towards the reimbursement claim of the project "Construction of Modern Hygienic fish market at Nedumankavu in Kareepra Grama Panchayath in Kollam District, implemented by Kerala State Coastal Area Development Corporation of which expenditure incurred from 30/01/2025 to 22/03/2025 and "Development of fish seed hatchery at Bhoothathankettu (Phase-II), Ernakulam" implemented through Periyar Valley Irrigation Project (PVIP) of which expenditure incurred

from 01/12/2024 - 28/02/2025 and has requested to accord sanction for the release of fund .

2. Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs. 75.15 lakh (Rupees Seventy Five Lakh and Fifteen Thousand only) for the following projects under RIDF Tranche XXV as detailed below under the H/A 4405-00-104-53(P).
