ORDER

As per the Government Orders read as 1st paper above, Administrative Sanction was accorded for the scheme "Revival of Traditional Water Bodies" for the financial year 2024-25. In the Annual Plan 2025-26 there is a budget provision of Rs.109.88 lakhs under the head of account 4402-00-102-99-Plan earmarked for the scheme "Revival of Traditional Water bodies".

2) As per the letter read as 2nd paper above, the Director of Soil Survey has requested Administrative Sanction for the project *Renovation of Thayappally (Kochuveli) Bhagavathi Temple pond, Kuttala Kshethrakkülam and Muriyanad Sastha Kshethrakkulam at Cherthala Municipality in Alappuzha District* under the scheme "Revival of Traditional Water bodies" for an amount of *Rs.109.88 lakh*s, by meeting the expenditure from the budget provision under the head of account 4402-00-102-99-Plan.

3) The Department of Working Group Meeting held on 19.05.2025 examined the proposal and has agreed for according Administrative Sanction for the scheme "Revival of Traditional Water Bodies" for an outlay of Rs.109.88 lakhs meeting expenditure from the head of account 4402-00-102-99-Plan during 2025-26.

- 4) Based on the decision of the Departmental Working Group, Government are pleased to accord Administrative Sanction for the project *Renovation of Thayappally (Kochuveli) Bhagavathi Temple pond, Kuttala Kshethrakkülam and Muriyanad Sastha Kshethrakkulam at Cherthala Municipality in Alappuzha District under the scheme "Revival of Traditional Water bodies" for an amount of <i>Rs.109.88 lakhs*, by meeting expenditure from the head of account 4402-00-102-99(Plan during 2025-26 subject to the general conditions of the Departmental Working Group.
- 5) The Project will be managed by the Additional Director, Department of Soil Survey and Soil Conservation and the project will be completed by *31.03.2026*. The Director of Soil Survey and Soil Conservation is authorized to draw and disburse the amount for the purpose.
- 6) The following general conditions should be followed, wherever applicable:
- i. All rules, formalities and procedures shall be strictly followed for the implementation of the scheme. The norms of financial propriety shall be adhered to.
- ii. The expenditure would be met only from the provision available under the appropriate head of account.
- iii. The fund release will be based on actual requirement, and the fund released should not be parked in banks.
- iv. Store Purchase Rules shall be strictly adhered to for all kinds of purchases.
- v. Tender/e-tender and other stipulated formalities shall be followed wherever necessary.
- vi. Post creation and purchase of vehicles are not admissible under the scheme.
- vii. The Head of Departments shall monitor the implementation of the

scheme and ensure that the implementation is as per the existing procedures, rules and regulations.

- viii. The implementation agencies/Departments also should prepare an implementation schedule to complete the project in time and send regular progress report on financial and physical progress on a quarterly basis.
- ix. The Director should hold monitoring meetings to review the progress and send report to Government regarding the progress of implementation of the approved scheme.
- x. The Director, Agriculture/Director of Soil Survey & Soil Conservation Department shall sign an MoU with the concerned implementing agencies of the scheme before releasing the funds. It should also be ensured that the Utilization Certificates pertain to all schemes are submitted by the agencies in time.
- xi. AIMS portal registration and Digital Soil Health Card is mandatory.
- xii. Geo fencing & Geo tagging is mandatory. It should be ensured in every scheme wherever beneficiaries exist.
- xiii. Plan review will be conducted on every month.
- xiv. The administrative sanction accorded is inclusive of the amount put under e-LAMS and amount need for encashing the queue bills.
