ORDER

Government had accorded administrative sanction for Modernization through installation of Autoconer and Yarn Conditioning Plant in Malabar Spinning & Weaving Mills for an amount of Rs.325 Lakhs during 2023-24, as per Government order read as 1st paper above. Out of this, Rs.100 Lakh was released as per G.O read as 2nd paper above. But the amount could not be utilized as this amount was not sufficient for purchase of machinery. Autoconer has to be imported and supplier will confirm the order only on receipt of Letter of Credit for the price of the machinery. Hence this amount was not utilised by the Company and is lying in the Treasury account of KSTC. As per the Government Order read as 3rd paper above, the administrative sanction was revalidated for the proposal for Modernisation through installation of Autoconer and Yarn Conditioning Plant in Malabar Spinning & Weaving Mills. As per letter read as 4th paper above, the Executive Chairman, BPT has reported that even though administrative sanction was revalidated during 2024-25 no amount was released. The e-tender was finalised during March 2025 and it was agreed to supply the machinery at 2% price reduction till December, 2025. Hence it is highly essential to open Letter of Credit for full price of machinery before

June 2025 for delivery of machinery by December 2025.

2) The Executive Chairman, BPT has submitted proposal for according revalidation of administrative sanction for Modernisation through installation of Autoconer and Yarn Conditioning Plant in Malabar Spinning & Weaving Mills, a unit of Kerala State Textile Corporation Ltd from the funds provided under the budget head of account 6860-01-190-95 of Kerala State Textile Corporation Ltd, and for an amount of Rs.225 Lakh during 2025-26.

3) There is a Budget provision of Rs.1886 Lakh for the financial year 2025-26 under the head of account 6860-01-190-95 for modernisation of all units of Kerala State Textile Corporation Ltd.

4) The Departmental Working Group Meeting of Industries Department held on 30.04.2025 considered the proposal for revalidation of administrative sanction for Modernisation through installation of Autoconer and Yarn Conditioning Plant in Malabar Spinning & Weaving Mills for an amount of Rs.325 lakh and release of Rs.225 lakh by meeting the expenditure from current year's budget provision under the H/A 6860-01-190-95.

5) Government have examined the recommendation of the Working Group and are pleased to revalidate the Administrative Sanction for Modernisation through installation of Autoconer and Yarn Conditioning Plant in Malabar Spinning & Weaving Mills, a unit of Kerala State Textile Corporation Ltd. for an amount of Rs.325 Lakh. Sanction is also accorded to utilize an amount of Rs.225 Lakhs for the project by debiting the expenditure from the current year's budget provision under the head of account of 6860-01-190-95 of Kerala State Textile Corporation Ltd.
