ORDER

Government as per Order read as 1st paper above have accorded Administrative Sanction for an amount of ₹60 lakh under the head of account '2235-02-190-97-34-3 (P)' to the Managing Director, Kerala State Welfare Corporation for Forward Communities Ltd towards Operational expenses (2025-26) of various Schemes to be launched by the Corporation.

2. The Managing Director as per letter read as 2nd paper above has requested to release the entire amount of ₹60 lakh as 1st installment for meeting the expenses in connection with the operational cost earmarked for the schemes to be launched by the Corporation during the current financial year(2025-26).

Government have examined the matter in detail and are pleased to release ₹ 12,00,000/- (Rupees twelve lakh only) as first installment to Kerala State Welfare Corporation for Forward Communities Ltd under the head of account '2235-02-190-97-34-3 (P)' for meeting the operational expenses of the schemes to be launched by the Corporation subject to the terms and conditions mentioned below.

*	The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/4/2018.
*	The instructions in Circular No.84/2008/Fin dated 09/12/08, Circular No.8/2018/Fin dated 30/01/2018 & G.O(Ms) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
*	The Corporation shall furnish duly authenticated detailed component wise statement of expenditure and utilization certificate in prescribed form as appended to the G.O.(MS)No.04/2020/Fin dated, 09.01.2020. Also, a certificate stating that audit charge is not due as per G.O.(Rt)No./93/2020/Fin dated 11/9/2020 should be submitted along with it.

*	The Unutilized portion of the amount shall be surrendered to the Government at the end of the financial year.
*	The amount remaining in the PSTSB account shall be spent only for the purpose for which it is sanctioned.

4. The Under Secretary, General Administration (Accounts-J) Department will draw and disburse the amount from the head of account '2235-02-190-97-34-3 (P)' to the PSTSB (Acct.no.799012700000550) of the Managing Director, Kerala State Welfare Corporation for Forward Communities Ltd.
