### ORDER

As per the letter read as 3rd paper above, the Ministry of Social Justice & Empowerment, Government of India, has issued the Mother Sanction for the release of Rs. 19,10,045/- (Rupees Nineteen Lakh Ten Thousand and Forty-Five only) as Central Assistance under the Grants-in-Aid Component of the Pradhan Mantri Anusuchit Jaati Abhyuday Yojana (PM-AJAY) Scheme for undertaking the activities approved under the Perspective Plan (PP) for 2025–26 as per the Scheme Guidelines during the current FY 2026–27 through the SNA SPARSH Module.

(2) Government have examined the matter in detail and are pleased to accord sanction for the release of Rs. 19,10,045/- (Rupees Nineteen Lakh Ten Thousand and Forty-Five only) to the Director, Scheduled Castes Development Department, from the Head of Account "2225-01-102-83(P)" under PM-AJAY for undertaking the activities approved under the Perspective Plan (PP) for 2025–26 during the current FY 2026–27 as per the Scheme Guidelines,, subject to the condition that the amount shall be operated through the SNA SPARSH

Module .

The Director, Scheduled Castes Development Department, is authorized to draw and disburse the amount for the aforesaid purpose, subject to the condition that the amount earmarked under the Grants-in-Aid Component shall be utilized exclusively for the respective category of beneficiaries, as mandated in the Mother Sanction.

(4) The Central Assistance under the scheme shall be drawn and operated strictly through the SNA SPARSH system, in accordance with the mechanism stipulated by the Government of India.
