### ORDER

As per the Government order read above, Government have accorded Administrative sanction for the proposal "Capacity Building Programme" of the Director of Industries &Commerce for an amount of ₹ 901,00,000/- (Nine Crore and One lakh only) from the head of account 2851-00-001-93 (Plan) in the financial year 2025-2026. One of the components in the above proposal "Intensive Industrialization in Kerala through KBIP" was sanctioned ₹ 200 lakhs. As per the request of CEO KBip, Director of Industries & Commerce vide letter read as 2<sup>nd</sup> above has requested to accord financial sanction to release an amount of ₹200 Lakhs from the head of account 2851-00-001-93 (Plan) and also to authorize Director of Industries and Commerce/Additional Director of Industries and Commerce to release the amount to KBIP by the way of Transfer Credit subject to the condition that further release will be considered only after furnishing the Utilization Certificate and expenditure statement of the released amount by the way of Transfer of Credit.

2. Government have examined the detail and are pleased to accord sanction to release an amount of ₹ 40 Lakhs (Rupees Forty Lakhs

only) under the head of account 2851-00-001-93(P) to K-Bip for **"Intensive Industrialization through K-BIP"** programme , and also authorized Director of Industries and Commerce / Additional Director of Industries and Commerce to release the amount to K-Bip by the way of Transfer Credit to PSTSB Account No.799012700002074 of Chief Executive Officer, K-BIP at Sub Treasury , Vikas Bhavan , Thiruvananthapuram, subject to the condition that further release will be considered only after furnishing the Utilization Certificate and expenditure statement of the released amount.
