The Director of Tourism as per letter read above had submitted a proposal before the Departmental Working Group for sanctioning an amount of ₹6,00,00,000/- (Rupees Six Crore Only) including GST for the project 'Upgradation and Renovation of Nalukettu Rooms and Palace Rooms at Bolgatty, Palace and Island Resort, Kochi', by meeting the expenditure from the head of account 5452-01-190-99-PV-Kerala Tourism Development Corporation Limited (Plan)

2. The Departmental Working Group on Plan Schemes 2025-26 that met on 31.05.2025 examined the proposal in detail and approved the proposal as detailed below:
