ORDER

As per the reference first cited Government introduced Electronic Ledger Account (ELA) system for facilitating Government Departments/PSUs. to ensure efficiency and continuity in utilisation of funds.

2.Government vide second paper cited above have issued Administrative Sanction for Small Hydro Power Hydro Kinetic Power Project for an amount of Rs. 450.00000 Lakhs (Rs. Four Hundred and Fifty Lakhs only). Since the sanctioned amount could not be expended in full during the last financial year, Government vide reference third cited have permitted to post an amount of Rs. 60.00000 Lakhs (Rupees Sixty Lakhs Only) to the Electronic Ledger Account (ELA).

3. Government therefore accord sanction to release an amount of 60.00000 Lakhs (Rupees Sixty Lakhs Only) for the implementation of the above components of the scheme.

4. The expenditure will be met from the budget provision under the head of account 2801-80-004-99-00-00-00-P-V during the financial year 2024-25.

5. The fund release will be subject to the following conditions,

i. The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/04/2018.

ii. The instructions in Circular No.84/2008/Fin dated 09/12/08, Circular No.8/201//Fin dated 30/01/2018, Go(Ms)No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.

iii. The Director, Energy management Centre shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in GO(Ms)No.4/2020/Fin dated 09/01/2020.

iv. If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.


