KERALA STATE BAMBOO CORPORATION SUBORDINATE SERVICE RULES

- 1. These Rules may be called the "KERALA STATE BAMBOO CORPORATION SUBORDINATE SERVICE RULES"
- 2. The service shall consist of the following Categories of officers.

CATEGORY I.

- (a) Divisional Officers
- (b) Office Superintendent
- (c) Vigilance Officer

CATEGORY II.

- (a) Depot Officer/Bundling Supervisor (Selection Grade)
- (b) Accountants / Cashier
- (c) Sales Executives
- (d) Personnel Assistant / Confidential Assistant.

CATEGORY III.

- (a) Depot Officer/Bundling Supervisor Grade I
- (b) Junior Accountant Grade I

CATEGORY IV.

- (a) Depot Officer/Bundling Supervisor Grade II
- (b) Junior Accountant Grade II
- (c) Typist Clerk

CATEGORY V.

- (a Field Assistants/Depot Assistants
- (b) Driver Grade I

CATEGORY VI.

- (a) Helper
- (b) Driver Grade II

CATEGORY VII.

- (a) Last Grade Employees
- 3. <u>APPOINTMENT</u>

Appointment to various categories of employees given above will be made by

(a) promotion from the feeder category

(b) selection or transfer from feeder category or any other category

(c) Direct recruitment as described in the Annexure to these rules.

4. **QUALIFICATION**

No person will be appointed to any category of post unless he/she possesses the qualifications prescribed for that post. Minimum qualification prescribed for different categories of post for appointment by promotion, selection or direct recruitment is given in the annexures.

5. PROBATION

Every person appointed to a category by direct recruitment shall be on probation for a period of one year within two years of service which may be extended to a further period of six months at the discretion of the Management .Those who are appointed by promotion or selection/transfer shall be on probation for six months.

6. RESERVATION OF APPOINTMENT

The rules relating to reservation of appointment to Scheduled Castes/Scheduled Tribes and Backward communities shall be followed in direct recruitments as per the directions from Government from time to time.

7. **TESTS**

Every person appointed to any of the Categories shall pass the Departmental Test prescribed, if any, for confirmation, promotion etc.

8. <u>SENIORITY</u>

When there are more than one feeder category carrying different scales of pay, they shall be shown a separate lists and persons in a lower scale of pay shall be appointed only after appointing all persons on a higher scale of pay. When the posts in the feeder categories are on the same scale of pay, the appointment shall be made in accordance with their seniority in the feeder category, the seniority being determined by the date of effective advice or the order of first appointment to that particular category, class or grade.

9. PROMOTION/SELECTION

Promotion to a higher category will be based on Qualification, Seniority and Merit. For appointment by Selection or Transfer, Qualification and Merit alone will be the criteria.

10. (a) All posts in the same category /grade are interchangeable provided the incumbent possess the qualification prescribed for the post. The

Management may deploy Officers of one category to any other category of the same or higher grade in any units under the Organisation.

(b) Appointment to posts in Category I (c) Vigilance Officer, Category II (c) Sales Executive and Category II (d) Assistant/Confidential Assistant will be by selection, based on qualification and merit only. All officers in Category I, Category II (c) and (d), Vigilance staff, Drivers and Security Staffs shall not have any Trade Union affiliation.

11. AGE LIMIT

Must have completed 18 years and must not have 36 years of age on the first January of the year inviting application for the posts with usual relaxation to SC/ST and OBC's for all appointments by Direct Recruitments. For selection of Helpers from Plant Workers and Depot workers, this will be relaxed to the extent of their service in the Corporation as Plant Workers / Depot workers subject to a maximum of ten years. All employees of this Corporation will retire on super annuation at the age of 58 years.

12. **DATE OF EFFECT**

These rules will come into force at once. But the qualification, method of appointment etc specified in these rules will not affect those who hold the post already. All future appointments, selection and promotions shall be done in accordance to these rules.

- 4. The rules regarding reservation of appointment are not applicable to By Transfer Appointment.

3. **APPOINTMENT**

Appointment to various categories of employees in the Bamboo Board Factory will be made by

- (a) Promotion from feeder category posts in Bamboo Board Factory or Selection from qualified hands in other categories of staff of the Corporation.
- (b) Work arrangement from other categories of employees of the Corporation.
- (c) Direct Recruitment.

Those who are appointed by selection from other categories of staff of the Corporation have to opt the service of the Bamboo Board Factory. They will be governed by the rules applicable to the factory with regard to working hours, bonus, production incentive, casual leave, spread .over allowance, supervisory allowance and other fringe benefits. Their original lien and seniority in Kerala State Bamboo Corporation will be protected and they can go back to the same at the discretion of the Management. But if one is appointed in a higher grade in the Bamboo Board Factory by selection, he will not be eligible for the same higher grade on reversion but will be in his original position and grade in the general category from where he was selected to Bamboo Board Factory, based on his seniority there. Those who opt the service of Bamboo Board Factory alone will be eligible for promotion based on grade seniority in the Bamboo Board Factory to the next higher post.

Any employee of the Corporation appointed to the Bamboo Board Factory on working arrangement will also be governed by the rules of the Bamboo Board, Factory. Selection to a post will be based on qualification, experience and merit only. While considering experience preference/weightage will be given for experience in feeder Category or similar posts in Bamboo Board Factory If the Selection is made from grades other than the same or the one next below, the selected incumbent will be given only a grade just above the one who holds. Selection to particular post will be made after considering eligible applicants for the same and will be based on qualification experience in Bamboo Board Factory and merit only. No employee in other cadre of Corporation can claim

promotion to higher posts in Bamboo Board Factory except by Selection as per these rules.

4. QUALIFICATION

A person appointed to a post by promotion, selection or direct recruitment shall possess the qualification prescribed for the post in Annexure, I & II. This will not apply to persons posted on work arrangement.

5. AGE LIMIT

Must have completed 18 years of age and must not have 36 years of age as on first January of the year in which applications are invited with usual relaxation to SC/ST/OBC. For selection of Plant workers from Depot workers attached to the Corporation, the maximum age limit is 45 years with usual relaxation to SC/ST. All employees of the Bamboo Board Factory will retire on super annuation at the age of 58 years.

6. SENIORITY

Seniority of Bamboo Board Factory Staff will be considered only among those who are appointed by promotion/Selection/Transfer and by direct recruitment to the Factory. Date of appointment to a category will be the criteria for seniority and promotion/ selection to next higher grade will be based on grade seniority. Seniority for those recruited directly by Public Service Commission in that category will be on the basis of the date of advice of Public Service Commission.
