### ORDER

As per reference read as first paper above, the Joint Director, Subsidiary intelligence Bureau has requested to assign 20.23 Ares of land included in Block No. 174, Re/Sy. No. 34 in Varkala Village, Varkala Taluk in Thiruvananthapuram District, on behalf of the President of India, in the name

of Joint Director, Subsidiary Intelligence Bureau for the construction of Office-cum-Residential Complex, before the District Collector, Thiruvananthapuram.

2 . The District Collector has reported that various institutions and organizations were allotted land from the above said 1.61 Hectares of land, and out of the remaining land, 20.23 Ares of land is suitable for the above purpose. The fair value of the land is Rs. 5,28,000/- per Are and considering the commercial importance of the said land, market value of the land is fixed as Rs. 12,85,007/- and the total value of 20.23 Ares of land is Rs. 2,59,95,692/-. As the Institute is functioning under Ministry of Home Affairs and taking into account the importance of the institution and its activities, the Commissioner, Land Revenue and District Collector vide references 2&3 have reported that decision can be taken at Government level to assign 20.23 Ares of land included in 1.61 Hectares of land in Block No. 174, Re/Sy. No. 34 in Varkala Village, Varkala Taluk in Thiruvananthapuram District, in the name of Joint Director, Subsidiary Intelligence Bureau on behalf of the President of India, by realizing the market value of the said land or free of cost.

4 . Government have examined the matter in detail and are pleased to assign 20.23 Ares (50 cent) of land included in Block No. 174, Re/Sy. No. 34 in Varkala Village, Varkala Taluk in Thiruvananthapuram District, on behalf of the President of India, in the name of Joint Director, Subsidiary Intelligence Bureau for the construction of Office-cum-Residential Complex by realizing market value of Rs. 2,59,95,692/- (Rupees Two Crore Fifty Nine Lakh Ninety Five Thousand Six Hundred and Ninety Two only).

5. The District Collector, Thiruvananthapuram will take further steps in this matter.
