#### **ORDER**

An amount of Rs.15.00 Lakh was provided under the Head of Account 2215-01-003-99-P(V) for the implementation of the scheme 'Information, Education and Communication (IEC), Capacity Building and Training & Jalasree Club' for the year 2024-25.
