ORDER

During the current financial year 2025-26, an amount of Rs. 300 lakh has been provided under the head of account 5475-00-800-77 (04) (PV) for the scheme Disaster Resilience and Disaster Management (Establishment of District/Taluk EOC's).

2] The objective of the scheme is to set up Taluk Emergency Operation Centres and District Emergency Operation Centres in connection with Disaster management activities. Establishment of Smart Control Rooms, Communication and Radio Equipments for establishing disaster resilient communication network, Capacity Building for staff and NGOs, logistics and conveyance for Disaster Management to inaccessible areas and imprest fund for meeting emergency disaster related needs at the disposal of the District Collector are the major components of the scheme.

3] The Commissioner, Land Revenue as per the letter read as 1st paper above has requested to accord administrative sanction for the scheme by utilising the current year's budget allocation of Rs.300 lakh under the head of account 5475-00-800-77 (04) (PV).

4] The Departmental working Group Meeting held on 22.05.2025 considered the proposal and approved the same.

5] Government are, therefore, pleased to accord administrative sanction for the proposal amounting to Rs. 300 lakh as per the budget break-up as detailed below.
