ORDER

An Industrial dispute relating to denial of employment to Sri.Baiju.M., who was working as Insurance Coordinator in Dhanalakshmi Hospital Private Limited, Kannur, was earlier referred for adjudication before the Hon'ble Labour Court, Kannur, vide reference order cited as 1st paper above.

2). Aggrieved by the said reference order, Sri.Baiju.M filed WP(C) No. 2846/2026 before the Hon'ble High Court of Kerala. As per the judgment cited as 2nd paper above, the Hon'ble High Court directed to pass a fresh order referring the dispute between the petitioner and the Dhanalakshmi Hospitals Pvt. Ltd. for adjudication of the Labour Court, Kannur.

3). Whereas, the Government are of opinion that an industrial dispute exists between 1)The management of Dhanalakshmi Hospitals Private Limited, Kannotheumchal Road, Kannur - 670 002, 2). Sri.C.M.Ramesh, (Medical Director, Dhanalakshmi Hospitals Private Limited), S/o Late.Ramunni, "Dhanalakshmi", Near Dhanalakshmi Weaving Works Private Limited, Kakkadu P.O, Kannur - 670 005, 5). Smt.Preetha Syam, (Director, Dhanalakshmi Hospitals Private Limited) W/o Syam, Dhanalakshmi Hospitals Private Limited, Kannotheumchal Road, Kannur - 670 002 and the workman of the above referred establishment Sri.Baiju.M, S/o K.Bhaskaran Nair, Sreepadman,

Kottakkunnu, Chirakkal P.O, Kannur - 670 011 in respect of matters mentioned in the annexure to this order;

4). And whereas, in the opinion of Government it is necessary to refer the said industrial dispute for adjudication;

5). Now, therefore, in exercise of the powers conferred by Section 10(1) (c) of the Industrial Disputes Act of 1947 (Central Act XIV of 1947) the Government hereby direct that the said industrial dispute be referred for adjudication to the Labour Court, Kannur. The Labour Court will pass the award within a period of three months.

6). This order is issued in full compliance with the judgment of the Hon'ble High Court of Kerala dated 05.03.2026 in WP(C) No.2846/2026.
