## **ORDER**

Government have accorded Administrative Sanction for an amount of Rs.3,79,17,241/ as per the order read as 1<sup>st</sup> paper above, for the construction of a LIFE Apartment (Housing Complex) comprising 24 units, in a land donated by Shri. Shameer Pookkuzhi. Also, Technical Sanction for Rs.3,79,17,241/- was issued by the Technical Committee on 20.02.2024. Subsequently an Agreement was executed between Secretary, Nellikuzhy, Grama Panchayat and LIFE Mission on 07.10.2023 as per which an amount of Rs.379.17 Lakh has to be given to Nellikuzhy, Grama Panchayat by LIFE Mission in five installments according to progress of work. The first installment of Rs.80 lakhs is to be released on commencement of the work as per the Agreement.

2. The Chief Executive Officer, LIFE Mission as per the letter read as 2nd paper above, has requested to release an amount of Rs.75,39,962/ from the head of account "4515-00-102-49 (P)" of LIFE Mission to the Secretary, Nellikuzhy, Grama Panchayat as first installment.

Government have examined the matter in detail and are pleased to release an amount of Rs 75,39,962 (Seventy five lakh thirty nine thousand nine hundred and sixty two rupees only) under the head of account "4515-00-102-49 (P)" of LIFE Mission to The Secretary, Nellikuzhy, Grama Panchayat and credited to STSB A/c No-:799013000001187 at Sub Treasury, Kothamangalam, as first installment towards the construction of LIFE Apartment under partnership project in LIFE Mission with Nellikuzhy, Grama Panchayat.
