ORDER

An amount of Rs.350.00 Lakh was provided under the Head of Account 4215-02-102-99-01-P-V and 4215-02-102-99-02-P-V for the implementation of the scheme 'Water Quality Monitoring and Surveillance of Community Managed Water Supply Schemes and Grey Water Management in colonies of vulnerable groups' for the year 2024-25. As per Government Order read as 1st paper above, the estimated cost for the proposed programme is reduced to Rs.130.00 lakh. Subsequently, as per the Government Order read as 2nd paper above, the Administrative Sanction was accorded for the reduced amount of Rs.130.00 lakh. Out of this, an amount of Rs.100 lakh was released as per Government Orders read as 3rd & 4th papers above.

2) As per the letter read as 5th paper above, the Executive Director, Jalandhi has informed that a total amount of Rs.100 lakh was received from Govt. through e-LAMS for the settlement of pending bills during the year 2024-25 (i.e; 50 lakh for Water Quality Monitoring and Surveillance of Community Managed Water Supply Schemes and Rs.50 lakh for Grey Water Management in colonies of vulnerable Group) and has requested to release the balance amount of Rs.30.00 lakh for

meeting expenditure in connection with the implementation of 'Grey Water management in colonies of vulnerable groups' programme.

3) Government have examined the matter in detail and are pleased to release an amount of Rs.30.00 lakhs (Rupees Thirty Lakhs only) under the Head of Account 4215-02-102-99-02-P-V for the implementation of the scheme 'Grey Water management in colonies of vulnerable groups' subject to the following terms and conditions of fund release.

- i. The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/4/2018.
- ii. The instructions in Circular No.84/2008/fin dated 09/12/08, Circular No.8/2018/Fin dated 30/01/2018 & G.O(Ms) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
- iii. The Executive Director, Jananidhi shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in GO.(Ms)No.4/2020/Fin dated 09/01/2020.
- iv. If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
