ORDER

1. The Ministry of Home Affairs as per the Order read as 1st paper above has sanctioned the third and final installment of Rs. 1.625 Crore for strengthening of DNA Analysis and Cyber Forensic Capacities in State/Forensic Science Laboratories under the Nirbhaya Scheme. As per Government Order read as 2nd paper above, Administrative Sanction was accorded for the procurement of items such as Instruments for establishing DNA Lab at RFSL, Kochi, items for DNA Lab of FSL and RFSLs, Machinery and equipments for Cyber unit at FSL and RFSLs by utilising an amount of ₹162.33 lakhs sanctioned.

2. The State Police Chief as per the Letter referred as 3rd above has informed that many items sanctioned have been procured and the procurement process has been completed for the rest of the items and an amount of Rs.7,34,141/- will be available as savings in the approved scheme after the procurement of all approved items. The State Police Chief has furnished a list of items such as Kits and chemicals and Labware which are urgently required for the functioning of the DNA unit at RFSL, Kochi and requested to give sanction for the procurement of these items by utilizing the savings amount of Rs.7,34,141/-(Rupees Seven Lakhs Thirty Four Thousand One hundred and Forty one only) under NIRBHAYA Scheme.

3. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the procurement of the DNA kits and chemicals and labware for the newly establishing DNA lab at RFSL Kochi by utilizing the savings amount of ₹7,34,141/- (Rupees Seven Lakhs Thirty Four Thousand One Hundred and Forty One only). The source of fund is GoI fund kept in the bank account of CNA, under Nirbhaya scheme .
