#### ORDER

As per the Government Order read as 2<sup>nd</sup> paper above, Sri. G.S.Santhosh was appointed as the Managing Director, Handicrafts Development Corporation of Kerala Ltd(HDCK). In the said Government Order, it was provisioned that the terms and conditions of the Managing Director will be fixed separately. Accordingly, as per letter read above, Sri. G.S.Santhosh, MD has requested Government to take necessary steps for the fixation of the scale of pay for the post of the Managing Director, HDCK.

2. In pursuance of the above, Government have examined the matter in detail and are pleased to fix the pay and other allowances along with terms and conditions of service of Sri. G.S.Santhosh, MD, HDCK

Ltd w.e.f. 23/09/2024, as per Government Orders read as 1<sup>st</sup> & 3<sup>rd</sup> paper above, as mentioned below:

### b) Medical Benefits:

As per G.O.(P) No. 131/2022/Fin dated 29.10.2022, the introduction of a Group Medical Policy for employees of all State PSUs shall be examined. Until such a policy is introduced, the existing medical treatment scheme of HDCK Ltd. shall be followed.

# c) Traveling Allowance (TA):

As per G.O.(P) No. 131/2022/Fin dated 29.10.2022, Each PSU is permitted to frame rules on Traveling Allowance (TA) in accordance with its financial capacity. Such rules shall be implemented with the approval of the Government. Accordingly, TA for the Managing Director, HDCK Ltd., shall be allowed as per the prevailing rules of the Corporation.

# d) Leave:

Leave for the Managing Director, HDCK Ltd., shall be granted as per

the prevailing rules of the Corporation.

- e) Other terms and conditions (As per G.O. read as 3rd paper above)
  - i. The appointment of Managing Director will be for a period of 5 years or till attaining the age of 65 years, whichever is earlier.
  - ii. Extension of term on completion of 5 years will be considered through performance evaluation based on specific criteria, in the case of those who do not attain 65 years of age.
  - iii. The first one year of the appointment will be probation period. Extension will not be given if the performance as Institution Head during probationary period is not satisfactory.
- 3. The above terms and conditions will be applicable to Sri. G.S. Santhosh w.e.f 23/09/2024
