ORDER

Administrative Sanction was accorded for the work 'Providing BM & BC Work in Kudutha Junction to Kottubhagum of Kalanjoor - Elamannoor Chayalodu Pattazhy Road Km 0/000 to 5/000' for an amount of ₹600.00 Lakhs vide Government Order read as 1st paper above and Technical Sanction was issued for the same amount vide order read as 2nd paper above and the work was awarded to Sri. K.N. Madhusoodanan Contractors Private limited.

2. The Chief Engineer, PWD Roads Division, Thiruvananthapuram vide his letter read as 3rd paper above has requested government to

accord Revised Administrative Sanction for the above work, incorporating additional GST amount, at an estimated cost of ₹6,02,41,000.00/- (Rupees Six Crore Two Lakh and Forty One Thousand Only) under the h/a 5054-04-337-99-00-16-00.

3. Government have examined the matter in detail and are pleased to accord Revised Administrative Sanction for the work 'Providing BM & BC Work in Kudutha Junction to Kottubhagum of Kalanjoor - Elamannoor- Chayalodu- Pattazhy Road Km 0/000 to 5/000' for an amount of ₹6,02,41,000.00/- (Rupees Six Crore Two Lakh and Forty One Thousand Only) under the h/a 5054-04-337-99-00-16-00, subject to the conditions noted below:

- i. The work was already completed as per the already approved Revised Estimate-1 and hence there is no scope for review at this stage. Hence the TS authority shall be satisfied himself that the RE-1 approved and executed, is as per the actual site requirement and necessity. TS authority shall ensure that the directions in the GO(P) No.54/2019/Fin dated 04-05-2019 & GO(Rt) No. 2997/2019/Fin dated 11-04-2019 are followed for RE-1 .
- ii. Directions in the Circular No. 79/2022/FIN dated 15-09-2022, shall be strictly followed for allowing increased GST rate.
