ORDER

An amount of Rs.400 lakh was allocated in the State Budget under the Head of Account 4215-01-800-85-(P) for implementation of the scheme 'Conversion of Domestic Wells into Protected and Sustainable Drinking Water Sources ' for the year 2024-25. As per Government order read as 2nd paper above, the estimated cost for the proposed programme is reduced to Rs.100.64 lakh. Subsequently, as per the Government order read as 3rd paper above, the Administrative Sanction was accorded for the reduced amount of Rs.100.64 lakh.

As per letter read as 3rd paper above, the Executive Director, Jananidhi has informed that during the year 2024-25, an amount of Rs.100.64 lakh was released and out of this an amount of Rs.73.68 lakh only could be utilized out of this, an amount of Rs.73.68 lakh was incurred as expenditure that no amount could be incurred as expenditure. Rs. 17.25 lakh has been resumed on 31.03.2025 by leaving an amount of Rs.9.71 lakh as balance in the PSTSB Account of
