ORDER

As per the Government Order read above, sanction was accorded for an amount of Rs.13.15880 lakh (Rupees Thirteen lakh Fifteen thousand Eight hundred and Eighty only) under the Head of Account "4405-00-104-53-00-00-00-P-V" towards the reimbursement claim of MATSYAFED for NABARD RIDF – Tranche XXVIII project, "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat, Chengannur."

2) The Director of Fisheries, as per the letter read above, has reported that due to ceiling restrictions imposed by the Finance Department, it was not possible to place the allotment or process the contingent bill through BAMS and hence the amount sanctioned as per the Government Order read above could not be credited to the account of MATSYAFED. The Director of Fisheries has therefore requested to revalidate the above Government Order for releasing the sanctioned amount for the timely completion of the project.

3) Government examined the matter in detail and are pleased to accord sanction to revalidate the Government Order read above, for releasing an amount of Rs. 13.15880 lakh (Rupees Thirteen lakh Fifteen Thousand Eight Hundred and Eighty only) to Matsyafed by debiting the expenditure from the

current year's 2026-27 budget allocation under the head of account 4405-00-104-53-00-00-00-P-V for the project "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayath".

4) The Director of Fisheries will take further necessary action in this matter.
