The Director, Scheduled Tribes Development Department, as per the letter read above has submitted a Project proposal for providing Flavoured Milk and Egg to the pre primary students of Model Pre Schools under Scheduled Tribes Development Department at an estimated cost of Rs. 32,77,500/- (Rupees Thirty Two Lakh and Seventy Seven Thousand Five Hundred only) to Government for consideration of State Level Working Group Committee.

(2) The State Level Working Group committee held on 07/06/2024 considered proposal and recommended for approval of the same.

(3) Government have accepted the recommendation of the State Level Working Group and are pleased to accord Administrative Sanction for the proposal providing Flavoured Milk and Egg to the pre primary students of Model Pre Schools under Scheduled Tribes Development Department at an estimated cost of Rs.32,77,500/- (Rupees Thirty Two Lakh and Seventy Seven Thousand Five Hundred only). The cost of Flavoured Milk (575 students @Rs.18, for 10 months @25 days per month) amounts to Rs.25,87,500/- and the cost of eggs (575 students @ Rs.10, for 10 months @25 days per month) amounts to Rs.6,90,000/-.
