The Director, KIRTADS, as per the letter read above has submitted a proposal for Training for youths from Scheduled Tribe Communities in Indigenous Food Items for their Socio Economic Security at an estimated cost of Rs.20,00,000/- (Rupees Twenty Lakh only) to Government for consideration of the State Level Working Group Committee. The training provides professionalization of cooking skills of the participants, to help them make an earning out of the traditional skills and knowledge of food culture. It also envisages to empower the office bearers of the Mahila Samakhya and to enhance their capacity for the protection and empowerment of women. The program also help the trainees to set up food stalls in tourist destinations which also ensures their economic empowerment.

(2) The State Level Working Group held on 07.06.2024 considered the proposal and recommended for approval of the same.

(3) Government have accepted the recommendation of the State Level Working Group and are pleased to accord Administrative Sanction for the proposal for Training for youths from Scheduled Tribe Communities in Indigenous Food Items for their Socio Economic Security at an estimated cost of Rs.20,00,000/- (Rupees Twenty Lakh only).
