#### **ORDER**

The Director, Scheduled Tribes Development Department as per the letter read above has submitted a Proposal for the Construction work of Compound wall and gate for Marampally Multipurpose Hostel, Ernakulam District, at an estimated cost of ₹99,35,000/- (Rupees Ninety Nine Lakh Thirty Five Thousand Only) to Government for placing before the State Level Working Group Committee.

- (2) The State Level Working Group held on 26/04/2025 considered the proposal and recommended approval of the proposal subject to the condition that amount should be at the reduced rate of ₹57,22,000/, as approved by CTE.
- (3) Government have accepted the recommendation of the State Level Working Group and are pleased to accord Administrative Sanction for

the Project Proposal for the Construction work of Compound wall and gate for Marampally Multipurpose Hostel, Ernakulam District, for an amount of ₹57,22,000/- (Rupees Fifty Seven Lakhs Twenty Two Thousand Only) as approved by CTE. The Director shall verify the estimate approved by CTE to ensure that the works proposed in the estimate shall satisfy the functional requirements as envisaged. If the work can't be completed with the approved amount by CTE, the Director shall place the matter before the next SLWG with proper justification with the approval of Finance Department.

- (4) Further the following conditions are also to be satisfied:
- i. The conditions laid down in the AS shall be followed strictly
- ii. The work shall be completed during this financial year itself
- iii. The Joint Director, Scheduled Tribes Development Department is appointed as nodal officer and is responsible for the executing / monitoring of the work and to ensure appropriate supervision through accredited engineers or other experts as may be required
- iv. The Director should ensure that the agreement with the Executing agency should have penalty clause for non performance/deviation/poor quality of execution
- v. The Director, Scheduled Tribes Development Department shall upload the Government order, details of the executing agency, details of the contractor, timelines, supervising officers and progress of the work on the departmental website. The contact details of the nodal officer shall also be published.
- vi. Monthly reviews on the progress of the project should be conducted to facilitate the execution and prompt report upon encountering issues, if any, to the Director, Scheduled Tribes Development Department for resolution.
- (5) Expenditure in this regard will be met from the Head of Account 4225-02-277-42 (P) Construction of MRS/Asramam schools /EMRS/Pre matric and Post matric hostels in tribal area.
