The Director, Scheduled Tribes Development Department as per the letter read above has submitted a proposal for Coaching for Banking Services, UPSC, KPSC and Staff Selection Commission examinations to 250 students at the rate of ₹30,000/- per student, at an estimated cost of ₹75,00,000/- (Seventy Five lakhs only) to Government for consideration of State Level Working Group Committee.

(2) The State Level Working Group held on 26/04/2025 considered the proposal and recommended approval of the same.

(3) Government have accepted the recommendation of the State Level Working Group and are pleased to accord Administrative Sanction for the proposal for Coaching for Banking Services, UPSC, KPSC and Staff Selection Commission examinations, at an estimated cost of ₹75,00,000/- (Seventy Five lakhs only) subject to the condition that an

internal monitoring mechanism should be implemented by the Director, Scheduled Tribes Development Department, with the support of the Planning Officer and the implementing agencies are to be empanelled by an internal Committee appointed by the Director, Scheduled Tribes Development Department.
