- (3) Government have accepted the recommendation of the State Level Working Group and are pleased to accord Administrative Sanction for the proposal for road concrete at Odapuzha Kurichya Unnathi, Kanichar Grama Panchayath, Kannur District, as per the Estimate No. LSGD/CELSGD/EST/13978/2022_5_1_1(Edit Id :3), at an estimated

cost of ₹15,93,000/- (Rupees Fifteen Lakh Ninety Three Thousand only) subject to the following conditions:

- i. The conditions laid down in the AS shall be followed strictly
- ii. Further requests for change in scope or content will not be entertained
- iii. The work shall be completed during this financial year itself
- iv. The Joint Director, Scheduled Tribes Development Department is appointed as nodal officer and is responsible for the executing / monitoring of the work and to ensure appropriate supervision through accredited engineers or other experts as may be required
- v. The Director should ensure that the agreement with the Executing agency should have penalty clause for non performance/deviation/poor quality of execution
- vi. The Director, Scheduled Tribes Development Department shall upload the Government order, details of the executing agency, details of the contractor, timelines, supervising officers and progress of the work on the departmental website. The contact details of the nodal officer shall also be published.
- vii. Monthly reviews on the progress of the project should be conducted to facilitate the execution and prompt report upon encountering issues, if any, to the Director, Scheduled Tribes Development Department for resolution.
- (4) Expenditure in this regard will be met from the Head of account 4225-02-102-90 Corpus Fund.
