ORDER

The XVth Finance Commission has recommended an amount of Rs.255 crore as Tied grant for Million Plus Urban Agglomerations for the year 2024-25. The undisbursed Grant of Solid Waste Management Component (SWM) of the Million Plus Challenge Fund in FY 2024-25 to other eligible Non-Million Plus cities (NMPCs) under XVth Finance Commission Award, amounting to ₹ 263.96 crore (ULB Release No.183/2025-26 dated 30/03/2026) has been authorized to Director (Urban), LSGD vide Government Order read as 2nd paper above.

2) As per FFC Guidelines the State has to release the amount with interest as per the average effective rate of interest on market borrowings/ State Development Loans for the previous year, for the delay in crediting the funds to Bank account of the Urban Development Department. There was a delay of 73 days in transfer crediting the Undisbursed Grant of Solid Waste Management Component (SWM) of the Million Plus Challenge Fund in FY 2024-25 to other eligible Non-Million Plus cities (NMPCs), to the Director (Urban), LSGD.

3) In view of the administrative delay caused in transfer of funds, Government, are pleased to authorize an amount of Rs. 3,90,62,913 (Rupees Three crore Ninety lakh Sixty Two thousand Nine hundred and Thirteen only) to Director (Urban)

LSGD as interest for the period of delay in transfer of undisbursed Grant of Solid Waste Management Component (SWM) of the Million Plus Challenge Fund in FY 2024-25 to other eligible Non-Million Plus cities (NMPCs) under XVth Finance Commission Award from the Budget Provision 2026-27 under h/a '2049-60-701-99-02-NC'.

4) The Under Secretary, Finance (Accounts) Department is authorized to transfer credit the interest amount from the head of account to the Bank account of the Urban Development Department opened for this scheme, as detailed below

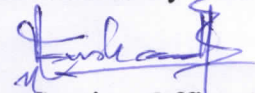
