An amount of Rs.341.10 Lakh has been provided under the head of account 2810-00-188-99 (Non-Plan) during the year 2024-25 for meeting administrative expenses including expenditure on salaries, rent, office expenses and other related expenses etc. of ANERT.

- **2**. As per Government order read above, an amount of Rs.68 Lakh has already been sanctioned as I<sup>st</sup> installment of grant-in aid for the year 2024-25 for meeting administrative expenses of ANERT.
- **3**. As per the letter read above, the Chief Executive Officer, ANERT has informed that the above sanctioned amount has been expended and requested to allocate Rs.2,73,10,000/- as 2<sup>nd</sup> installment of Grant-in-aid under the head of account 2810-00-188-99 (Non-Plan).

Government have examined the matter in detail and are pleased to release Rs.75,00,000/- (Rupees Seventy Five Lakh only) to ANERT as 2<sup>nd</sup> installment of Grant-in-aid for meeting the administrative expenses including salaries from the budget provision under the head of account 2810-00-188-99-36 (NPV) for the financial year 2024-25 subject to the following terms and conditions of fund release.
- 1. The amount shall not be parked in Banks / Financial Institutions other than treasuries as non interest bearing STSB accounts.
